Karrolla Babu S/o Mallaiah, Caste: SC Madiga, Occ: Advocate, R/o Siddipet Town and District he along co-advocates together created two whatsapp groups with name and title as ADVO Friends (Siddipet Ditriect) and District BAS (near & Dear). On 20.09.2025 at about 1355 hours the group member i.e., Prodduturi Srikanth, Caste: Vysya, Age: 38 Yrs, Occ: Advocate, R/o Siddipet Town posted by insulted the caste and dignitary position of Justice Sri. Bhushan Ramakrishna Gavai, Hon'ble Chief Justice of India for Hon'ble Supreme Court as "Kanakapu Simhasanam" in the said two whatsapp groups from his mobile phone number 9030784390. On the same day at about 1507 hours another member M. Murali Mohan Rao, Caste: Vysya replied for the said post as "Venukati Uri Shunakalu Malam Thinevi Venukati Shunakalu Malli Vasthayi Anukoledu" Prasthuthaniki Delhilo Okato Labyamainadi" by insulted caste and dignitary place of the Hon'ble Chief Justice of India and dignitary of the Hon'ble Supreme Court as well as all the Indian SC Caste people. Hence he requested to take necessary legal action. Received on 21.06.2025 at 2030 hours. As per the contents of the petition I D. Navatha, registered a case in Cr.No. 452/2025 U/s 353 BNS and Sec. 3(1)(r)(s) of SC & STs (POA) Act and took up the investigation. Sd/- Sub-Inspector of Police, PS Siddipet-I Town.
